E. TERMS AND CONDITIONS

1. Introduction.

1.01 These Terms and Conditions on which SHK Diamond (Surat) will submit diamonds for inspection and the result will be declared by tender/auction in which the name of the purchaser will not be disclosed. Online tender/auction will be done through tender/auction platform.

1.02 The Company Owner and all its representatives wishing to purchase the diamonds represented by SHK Diamond are bound by these Terms and Conditions.

1.03 The Terms and Conditions are available on the online tender/auction platform, and each customer confirms that he has read them and agrees to be bound by them as registered as a customer. Although included here, nothing will seem contradictory and then even if the customer registration is completed and the terms and conditions are amended, the customer agrees and the amendment must be validated by the customer so that the customer reads and understands the terms and conditions each time and he will be bound by the revised terms and conditions available on the online tender/auction platform.

1.04 The customer (company owner) agrees that when his representative or himself on the online tender/auction platform select "**I accept**" and submits an electronic bid, the customer confirms the acceptance of the terms and conditions effective at the time of the tender/auction, as electronic proof that he is legally bound by them. Each customer further agrees that the electronic signature is the legal equivalent of a manual signature, which has the full power and effect of a handwritten signature on a paper document, and which any certifying authority And / or approval from others is not required.

1.05 Terms and Conditions apply to the entire online tender/auction process and to other services provided by SHK Diamond to registered customers.

2. Customer registration.

2.01 Any company wishing to participate in the tender/auction organized by SHK Diamond must apply for

this purpose by filling up the registration form provided by SHK Diamond to become a customer of SHK Diamond and such All documents are required, including proof of customer identity, such as its director, representatives and customer's constitutional documents and copies of business license and company bank account details.(See customer registration form for full details of documents.)

2.02 All information and documents provided only after thorough verification, The full right to register or not to register with the customer is reserved by the seller or SHK Diamond and customers who are already registered must keep such information and documentation updated at all times, in which the SHK Diamond may request to company and representatives to submit proof of identity at any time.

2.03 To be recognized as a customer, each applicant must meet all requirements of SHK Diamond safety, compliance and other appropriate diligence requirements. The registered customer is then referred to as our 'customer'.

2.04 The Customer assures that it has the legal capacity to discharge its obligations under these Terms and Conditions.

2.05 SHK Diamond, in its sole discretion, may cancel the registration of a customer, and refuse to admit any of its representatives on inspection or tender/auction without notice and with immediate effect.

2.06 SHK Diamond may list the registered customer in its website or advertisement after obtaining the company name and logo with the consent of the company, such as "**Valuable Customer**" under several other such headings.

3. Invitation and inspection plan.

3.01 SHK Diamond invites customer to participate in tender/auction after successful completion of registration process, successful registered customer will be invited to check diamonds for sale on online tender/auction.

3.02 SHK Diamond will decide at its sole discretion whether to invite the customer to participate in the tender/auction or not.

3.03 SHK Diamond shall have no obligation to invite the customer to participate in the tender/auction, whether such customer has participated in the previous tender/auction or whether such customer has successfully completed the registration process.

3.04 SHK Diamond may, at its sole discretion, change or cancel the date, time, period and place of inspection as determined by time and circumstances.

3.05 The inspection will take place only at the SHK Diamond premises or at a place designated by SHK Diamond.

3.06 SHK Diamond may, at its sole discretion, publish a description of a lot of diamonds or diamond parcels to be inspected on that tender/auction. Such a description will be indicative only; will not make any representations for the quality and quantity of diamonds or the exact weight of lots, which will be available on tender/auction. **(Comparison between two tender/auctions is never fair)**

3.07 In the bank account designated by SHK Diamond, as a bank guarantee from the customer, a deposit may be required before inspection. (If the customer has not received the tender/auction in any previous tender/auction, or the customer has failed to make the successful payment in the previous tender/auction) The deposit is refundable 2 to 3 working days after the closing of the tender/auction.

3.08 Invitations and appointments made by SHK Diamond for online tender/auction process are given on a first come first served basis based on fully automated software.

4. Representation during the inspection.

4.01 If the customer wants to bring a consultant or any third party person who is not an employee of his company or any of his subsidiaries for inspection, the customer has to inform the SHK Diamond or the inspection appointee in advance and submit proof of third party identity. The third party person will also be considered a representative of the customer, and will meet the same security, compliance and other reasonable requirements as the customer and his other representatives. Customers will be legally responsible for all representatives brought in for inspection. SHK Diamond reserves the right to refuse to allow any third-party person to attend the inspection visit at its sole discretion. (for security purpose, maximum two person of single company are allow for inspection)

4.02 The Customer issues a warrant and ensures that its representatives are fully aware of and comply with the Terms and Conditions.

5. Online tender/auction platform.

5.01 bids must be submitted to the dedicated SHK Diamond tender/auction platform, which is specifically designed to be as intuitive and user friendly as possible.

5.02 Website Address of Online Tender/auction Platform to Customer will be informed during the inspection of the tender/auction or will be informed earlier by various means.

5.03 At the time of inspection the customer may request training on how to use the online tender/auction platform on which bids are to be submitted. For technical guidance during the bid submission process, the customer may contact the inspection office by telephone if necessary.

5.04 Customer agrees not to use the online tender/auction platform for any purpose other than participating in the tender/auction.

5.05 At the time of registration, each customer is given a unique username and password to access the online tender/auction platform. The customer will be responsible for maintaining the security and confidentiality of his details and In case of loss or theft of login details will report immediately. Seller / SHK Diamond is not responsible at any time for misuse of your login password and username.

5.06 The customer (company owner) represents and guarantees that bids submitted by any of its representatives or employees on the online tender/auction platform, will be submitted by the person who is legally authorized to take financial commitment on behalf of the customer (company owner). The seller and / or SHK Diamond will have no obligation to verify the financial authenticity of any customer representative.

5.07 The process of online tender/auction platform is technically "as it is". The seller and / or SHK Diamond do not guarantee uninterrupted access to the online tender/auction platform and will not be responsible for any technical issues.

5.08 Where the customer is unable to submit a bid through the online tender/auction platform (due to failure of the seller and / or SHK Diamond devices, or to the customer, or any other person or due to difficulties in internet connection, etc.) SHK Diamond, in its sole discretion, is entitled to accept a properly signed bid from the customer in an email, or in a sealed envelope, before the end of the bid submission period.

5.09 In the starting of online auction, the bidding company (Bidder) will see the starting price of each lot before bidding. They have to enter bid value more than or same starting price to enter the first round of the auction. The starting price is only for entry into the first round of the auction. Start price is not the reserve price or the base price

5.10 A some number of pre-defined rounds will be created by the organizer of the online auction. which will be automatically created by the software as per the demand of the lot or activity of participants of competitive bids . Auction will be considered completed after the final decision has been taken by the software regarding each lot of the auction.

5.11 The online tender/auction platform contains confidential information, which is the sole property of the seller and / or SHK Diamond. The customer will not use the online tender/auction platform to suit the purpose of reverse-engineering / theft and / or logic, general aesthetics or any part of its content. If a third party becomes aware of any unauthorized use of the content of the online tender/auction platform, the customer will inform the seller / SHK Diamond.

6. Security during inspection.

6.01 The SHK Diamond will be entitled to observe the inspection during the tender/auction process by devices such as video cameras and other surveillance, to which the customer and his representatives have specially agreed.

6.02 Customers or their representatives will not have any diamond or diamond related option in their possession while entering or leaving the inspection premises, they will not be admitted in the tender/auction if they are found to be bringing any type of diamond or diamond related option. (Therefore, do not bring the diamond related options or diamonds when entering the tender/auction and leave the inspection room only after taking special care to check that no diamond or diamond related options are left on your body part by mistake)

6.03 No more than two persons at a time shall enter the room allotted for inspection for security purposes.

6.04 SHK Diamond will record the weight of each Lot before and after each inspection of the diamond or diamond Lot given to the customer.

6.05 Where there is a discrepancy between the weight recorded after inspection and the weight recorded before that inspection, the seller / SHK Diamond reserves the right to suspend the delivery of all goods, and will be entitled to search in that area, in which the observation was made and it will not be entitled to leave the premises unless the seller / SHK Diamond otherwise approves and the customer and his representatives are matched with the discrepancy.

6.06 Each Customer agrees, that all its representatives agree that, at its sole discretion, SHK Diamond may take any security measures, any customer representative's present, consent to a thorough inspection or it can stay on campus until it feels right before it leave premises. (In which the weight of the observed diamond is not limited enough)

6.07 Any suspicious behaviour committed by a customer or any of his / her representatives may be further investigated by SHK Diamond and may be referred for criminal investigation.

6.08 If a diamond inside particular Lot is either lost or severely damaged during inspection, the customer will be entitled to charge as per carat value or at the reserve price of the Lot, whichever is higher, depending on the officer appointed by SHK Diamond.

6.09 SHK Diamond shall not be liable for any loss or damage to the customer in the premises or any compensation shall not be paid including liability for death or personal injury.

7. Behaviour during inspection.

7.01 If a customer fails to be present for inspection at the appointed time (if the failure to attend is more than twenty minutes late for adjustment) the seller / SHK Diamond may, in its sole discretion, refuse to allow the customer to be present for inspection. SHK Diamond has the full right to refuse to participate in the tender/auction

to the customer at a later time according to the appointment availability and / or except.

7.02 The presence of an approved inspection is not limited to one visit per customer only and a maximum of two (2) representatives per customer. The Seller / SHK Diamond may, at any time and without prior notice, limit the number of submissions of any customer's observation at its sole discretion, to a lesser number corresponding to the time.

7.03 During the inspection, the description of any Lot made by the seller and / or SHK Diamond is only providing information, and the nature, size or quality of the goods are not guaranteed. It is the customer's responsibility to thoroughly inspect all lots before submitting any bids. Customers should have a thorough and detailed inspection of all the diamonds / goods before bidding. The Customer agrees that seller and /or SHK diamond are to be responsible for any description or information provided about any diamonds / goods.

7.04 Prior to inspection, customers are requested to check the weight of each lot they have submitted and to report any discrepancy in text and actual weight on the parcel or any internal discrepancy is noticed to the seller / SHK Diamond immediately.

7.05 During inspection, a Diamond or Diamond lot inspected by customers will not be given for second inspection. So make sure Inspection done properly in first attempt.

7.06 Each Lot is sold as a whole and will not be mixed or split from its original presentation.

7.07 Diamond Lot for inspection is distributed to the customer through automated software method. In certain circumstances the customer may be busy with some Lot during the request for some diamond Lot for inspection. In such circumstances the customer or his representative is bound to show complete restraint.

7.08 Customers are not allowed to apply white or any other collared coating to the diamond being examined, as it changes the alleged colour of the diamond for subsequent inspection. The seller / or SHK Diamond reserves the right to immediately disqualify customers who do not comply with this restriction and the customer will be solely responsible for any damage caused by the seller / SHK Diamond for non-compliance. Marking with ink, where it is easily removed from ethanol, is allowed, (Only for rough diamonds) .

7.09 Customers will have to leave the inspection room at the end of their appointment period, the seller and / or SHK Diamond will allow the customer to leave the premises before the appointment period only after checking all the diamonds / goods.

7.10 Special care should be taken by the customer or his representative not to mix any diamond Lot knowingly or unknowingly. However, if more than one Lot is mixed, the customer agrees that the decision of the seller SHK Diamond will be final.

7.11 The customer and his / her representative agree to follow the instructions given by the seller and / or SHK

Diamond to maintain and respect the privacy and security of other customers and to inspect and bid on diamonds.

8. Result opening

8.01 Sellers and / or SHK Diamond will open the final stage submitted bids only after the bidding period closes and only under the supervision of the Appointing Committee. (Which is a fully automated "automatic" base.)

8.02 The seller, in his absolute discretion, may determine the reserve price at which he is willing to make a particular sale and may at any time reduce or discount it.

8.03 Seller and / or SHK Diamond are not bound to announce the reserve price of any particular lot tender/auctioned to any customer and to announce the result price.

8.04 The Seller may, at its sole discretion, accept or reject any submitted bids.

8.05 Where two or more customers are bidding the same winning prices, the seller and / or SHK Diamond will contact each customer by phone to inform them that they are the joint-highest bidder with one or more parties, and their bids offers an opportunity to review the price. If both customers are inaccessible or decide to bid the same within thirty minutes after being notified, the seller and / or SHK Diamond will decide by lot in the presence of the Appointments Committee, with the highest bidder will be the winner.

8.06 When the customer admits his mistake on the online tender/auction platform, the decision will be taken after reviewing the bid made by the customer by the seller or the appointing officers of SHK Diamond which will be considered final.

8.07 Seller and / or SHK Diamond Online will be entitled to publish on this tender/auction platform and send the final results of the tender/auction to the bidding customers by email, but are not bound.

8.08 In the event that there is no customer bidding more than once on a particular parcel, the seller / SHK Diamond is entitled to decide according to his discretion whether to declare the customer as an uncontested winner.

9. Bid submission.

9.01 Online tender/auction at any time. The seller and / or SHK Diamond are not bound to sell the tender/auction even after the bidding (bid submission process) is completed. (Note that bid means offer which can be linked to Indian Rupee (Rs) or US Dollar (\$))

9.02 To protect the customer from over-stretching or stress the Budget and to bid with complete confidence, the customer may be requested to predefine their overall 'purchase limit', i.e. the customer is ready to purchase the maximum amount. (for which online tender/auction the Platform page will have a bar to set limit of purchase by which the customer can set his purchase limit)

9.03 Customers may change their purchase limit at any time before the end of the bid submission period.

9.04 Customer bids, which have not been submitted through the online tender/auction platform, may also bid through the sealed envelope specified by the customer and by email (subject to approval) in the bid given in the sealed envelope. That type cannot be changed, while the bid placed on the online tender/auction platform can be changed before the expiry of the bid. The customer who wants to bid in a sealed envelope and in Email should take special note above. Bid given in email and cover is for tender only and not for online auction

9.05 The bidding currency / value is in Dollars (\$) or Rupees (Rs) and must be entered in respect of each lot as directed by that lot.

9.06 Bids may be entered in the amount per carat (\$ / carat) / (Rs / carat) or in total value per lot (\$) / (Rs), which is entered in the field. The other field is calculated automatically.

9.07 The bid submitted by the customer on the online tender platform only can be submitted, edited or cancelled at any time till the end of the submission period.

9.08 The customer will not be entitled to withdraw the bid made after the end of the bid submission period.

9.09 Once the submission period is over, any bid will be on standby as an offer to buy lots.

9.10 Customers will not receive a notification email for submitted bids, or when the submission period closes.

9.11 In the process of online tender/auction platform, only the customer company will be held responsible for the mistake in the bid submitted by him.

10. Terms & Conditions ,Transfer of Right & other rights

10.01 These terms and conditions by the seller and / or SHK Diamond may change, or delete any of the previous terms in respect of the sale of diamonds through the online tender/auction platform.

10.02 The Seller and / or SHK Diamond will be entitled to amend or modify the Terms and Conditions to make such revised Terms available on the Online Tender/auction Platform, prior to the customer participating in the tender/auction, to which the revised Terms apply. Therefore, it is imperative that the customer reads the terms and conditions carefully before making any bid.

10.03 For reference purposes, the current version of these Terms and Conditions will be available on the website of the online tender/auction platform.

10.04 The Customer shall note that these Terms and Conditions Agreements with the Seller and / or SHK Diamond are not entitled to be transferred to any third party without the prior written consent of the full or partial seller without the prior written consent of SHK Diamond, Any assignment or transfer will be considered void.

10.05 Right to move the physical tender/auction site.

10.06 Right to change tender/auction schedule.

10.07 Right to withdraw many parcels (diamond lot) from sale at any stage before the end of the bid submission period.

10.08 Right to prevent any customer from accessing online tender/auction platform.

10.09 Right to reject any bid at any stage prior to the existence of the binding agreement of sale.

Note: - All the above rights are vested by customer to seller and / or SHK Diamond.

11. Payment.

11.01 The seller reserves the right to refuse to sell the lot in full even after the bidder has successfully won the lot and the seller and / or SHK Diamond reserves the right to do so.

11.02 The binding contract of sale in respect of the seller and any diamond or diamond lot won by that customer will be done after successfully payment.

11.03 The seller and / or SHK Diamond will issue an invoice in dollars or rupees for the lot won in one working day after announcing to the winning customer.

11.04 During the inspection of a tender/auction related diamond, the weight of a given lot may be reduced by a few carats. This marginal difference is proportional to the initial carat of the lot, and may result in a change in weight due to the friction of the diamonds against each other or as a result of one small particle coming out of the same diamond. By bidding on many of the tender/auctioned lots, customers recognize and accept this risk of marginal weight loss in the handling of goods. Prior to invoice, the seller and / or SHK Diamond will adjust the weight of the winning lot to ensure that the winning customer can pay the appropriate total price based on the final weight of the lot.

11.05 After each winning customer sends his invoice via email from the seller and / or SHK Diamond, the winning price (net price) of each lot which is sent by electronic bank transfer to the bank account specified in his invoice within five working days. / Or payment in favour of Seller/ or SHK Diamond.

11.06 This invoice will be given only to the winning customer and payment will be accepted from the bank account specified in the customer's registration form. Customers can split payments between different companies through different bank accounts as long as the customer is already registered as SHK Diamond customer before the tender/auction starts.

11.07 In case the customer is unable to pay the invoice from the bank account specified in the registration form, the customer wants to use the seller and / or SHK Diamond in writing any different bank account details to pay the invoice. The seller and / or SHK Diamond are not under any obligation to accept payment from the alternate bank account specified in the customer's registration form.

11.08 The bank account details on which the payment should be made will be specified only on the invoice issued by the seller and / or SHK Diamond. Such invoice will only be sent by email and the seller and / or SHK Diamond will never send separate instructions to any customer to change the bank account details. Apart from this the customer receives a notice regarding the bank account details which is notified to the customer by the seller and / or SHK Diamond that such notice may be fraudulent (hence the customer, by his own discretion should be investigated at the office) and the customer will be solely responsible for any damage incurred depending on it.

11.09 Any payment by the customer is taken on the seller and / or SHK Diamond charge, the amount charged by the bank during the payment made from the bank and in addition the bank charges etc. must be paid to the customer.

11.10 If a customer fails to pay the price in such a situation the customer will not be able to raise any objection in selling the winning lot to the seller / SHK Diamond and such company will be declared default, the customer agrees that SHK Diamond has the right to charge a default fee of 10% (above the winner's total price) to limit its losses (including the difference between the lot price and the winning price may be apply). A customer who sells diamonds may be excluded from participating in any future tender/auctions. The customer expressly agrees that the default fee is not a penalty and the seller and / or SHK Diamond may retain the deposit for recovery of the default fee.

11.11 Winning diamonds or parcels of diamonds from the online tender/auction platform by the seller or SHK Diamond whose price option is USD (\$) at the time of making that invoice at the price of USD (\$), Indian Rupee will be converted which will be an invoice given to the customer of the diamond or diamond parcel sold at the end of the tender/auction process considering the dollar price according to **Section 13.04**

11.12 Working days can mean any day in India which is not a weekend or public holiday.

12. Collection and delivery.

12.01 The winning customer will be able to collect Lots from the SHK Diamond premises only after receipt of full payment (including charges, if applicable) by each winning customer.

12.02 Swift copies cannot be accepted as a way to unload goods (for customers outside India only)

12.03 The title of ownership in the winning lot will be awarded to the winning customer upon receipt of full payment.

12.04 Additional insurance and storage charges may be charged from the winning customer in case the winning lot has not been collected within two working days after receipt of full payment.

12.05 If the winning customer requests to send the winning lot, it is in the sole discretion of the seller and / or SHK Diamond to agree to arrange such a trip, in which case

the seller and / or SHK Diamond ship to the winner will inform the customer about the details.

12.06 The winning customer acknowledges and agrees that all risk of loss after crossing the premises of the seller's premises will be under the liability of the customer even if the seller and / or SHK have agreed to arrange diamond shipment after crossing the boundary of the seller's premises, Insurance of the winning lot will be the responsibility of the winning customer.

12.07 All transport, export, shipping insurance, diamond office tax fees and related expenses, will be in the customer's account to be paid before the movement of the winners.

12.08 Customer to comply with, submit and warrant all laws, export / import control and trade approval laws and regulations not limited to, which may apply to the winning lot. This compliance is the sole responsibility of the customer and the seller and / or SHK Diamond will not be liable for any violation of export / import and clearance rules by the customer.

12.09 Return of goods after collection or delivery will not be accepted under any circumstances.

13. Winning customer acknowledgement.

13.01 The winning customer acknowledges and agrees that he has been given the sufficient time to inspect the diamonds he has purchased, his sole responsibility is to fulfil his due diligence regarding the diamonds purchased Not based on any information, representation or warranty provided by the seller and / or SHK Diamond.

13.02 Diamonds or diamond lot will be given to each customer for inspection only during the tender/auction period. Diamonds or diamond lot will not be given for inspection after the bids for tender/auction have been completed.

13.03 Buyer (Winning customer) who has won the the certified polished diamond / Diamond parcels (deal) as per back/discount of it, they are bound to agree the price of rapaport of the ending(result) day of tender/auction.

13.04 Buyer (Winning customer) who won in dollar currency with respect to lot and if they are Indian customers then they have to consider dollar conversion rate of result day of tender/auction and bound to agree. (dollar closing rate of india) , if overseas customer, they are bound to agree the terms of banking

14. Conflict and privacy.

14.01 No customer shall disclose any information relating to the tender/auction to any other customer or any other person without prejudice to the generality of the meaning of the phrase, "tender/auction related information" will be included.

14.02 If a customer is found to be in violation of this law even though the lot is not identified, or photographed or shared, the right and consent to leave it immediately from the premises is given by the customer to the seller and / or SHK Diamond, the customer will bid at his own discretion without being deceived by any third party.

14.03 SHK Diamond is not under any obligation to deliver any winning diamonds or diamond parcels to the customer. The customer has to collect diamonds or diamond parcels from SHK Diamond office by himself or his representative.

14.04 To avoid any conflict of interest, the seller and / or SHK Diamond will not bid on many tender/auctioned diamonds or diamond parcels.

14.05 It is at the discretion of the seller to declare the bid prices as the winner.

15. Private statement.

15.01 At SHK Diamond we are committed to protecting the privacy of your personal information and other data provided to us by e-mail, phone or any other SHK Diamond online bidding platform.


